Please read all points listed below carefully. These rules and requirements will be strictly enforced. Action will be taken if these rules are violated:

****FIRST Offense:** Verbal warning

****SECOND Offense:** Written warning,

****THIRD Offense:** May result in a directive to remove Golf Cart from Sleepy Oaks Campground Association

- 1 A golf cart is defined as a gasoline or electric powered cart that carries golfers on public and private courses. This does not include:
 - 1.a Side by Sides (S x S, UTV)
 - 1.b Argos
 - 1.c ATV's
 - 1.d Or any other utility type vehicles
- 2 Co-Owners MUST carry insurance (\$100,000 liability) and be able to show insurance information upon request of any Director.
- 3 Anyone that operates a golf cart MUST be 16 years of age or older AND must possess a valid driver's license. Operators must agree to show any Director upon request.
- 4 Golf carts are to be operated only on the park roads and observe all "rules of the road", to include (but not limited to): speed limits and stop signs. Any damage caused by off-road tires will be the responsibility of the owner and operator. NOTE: Golf Carts may be operated on back streets of AuGres with City Permit. You may not ride your cart on 23 but may cross the Main Street to access the park for frequenting the Music in the Park or other events.
- 5 There must be a seat for each person riding on the cart (if there is no rear seat, then no one is allowed to ride there). No children are allowed to sit on the driver's lap while the cart is in motion.
- 6 All carts must have working headlights and taillights, rear reflectors (red) are acceptable. No flashlights!!! Brakes must be in good working order.
- 7 Only one golf cart per unit is allowed. Cart owners are responsible for family members and/or guest's behavior while driving/riding on the cart.
- 8 No modifications to the golf cart will be allowed that will result in the golf cart being louder than what was intended.
- 9 Operators will allow any Director to examine the cart at any time to verify compliance with the above regulations.

*******I have read and understand the rules/regulations above and agree to follow them. I further understand that the failure to comply may result in my cart being removed from Sleepy Oaks Campground Association. Further, I understand that any Director will have the final say on acceptance/rejection of any golf cart.
